

Return Policy

Our goal at Ag Express Electronics is to provide excellent service and support to all of our customers. If our support team cannot resolve problems with the items you purchased, most non-custom items are returnable within 30 days of delivery. While we would like to offer that option for all of our products, some standard products will have different return/replacement policies based on requirements from our vendor/s. All custom and special orders are non-cancellable and non-refundable.

To verify if your purchase is eligible for return and/refund, don't hesitate to get in touch with Ag Express Electronics. Our helpful sales team can approve and quickly prepare a return authorization for you.

0 to 30 days - Authorized Non-Custom Item Returns

During the first 30 days, Ag Express will not charge any restocking fees on authorized returns. Returned products must be in new, unused condition and include all original packaging.

- *Ag Express will not cover any return shipping charges (including insurance).*

30 to 60 days - Authorized Non-Custom Item Returns

From 30 - 60 days, Ag Express will charge a 15% restocking fee on authorized returns. Returned products must be in new, unused condition and include all original packaging.

- *Ag Express will not cover any return shipping charges (including insurance).*

- *No returns will be authorized after 60 days.*

Damaged/Used Returns

If the items returned to Ag Express Electronics are used, damaged, or dirty we reserve the right to withhold all or part of the refund to return the items to sellable condition. Judgments regarding the condition of returned items are at the discretion of Ag Express alone.

Returns

Ag Express Electronics will authorize most returns within three to five business days of receiving the returned merchandise. Credit card refunds typically process within five business days of the return authorization.
